## **BARE GROUND :**

Bare space is reserved for the exhibition of outdoor equipment.

Minimum area : 16m<sup>2</sup> - 4X4

Bare space is reserved for exhibition of outdoor equipment .

Every application will receive 10 invitations to the event, valid for the admittance of one person on, either Saturday or Sunday.

## **TENT**

All marquees are "Garden Cottage" type, white and sheeted on four sides. They come equipped with flooring , a 3 KW electricity socket and a 500 W halogen spot. This will leave 1500W of useable power. If you require any more, remember to book extra KW.

Every application will receive 20 invitations to the event, valid for the admittance of one person on, either Saturday or Sunday.

## **PAYMENT**

No reservation will be accepted without payment.

There will be not refund after 13th September 2019, a deposit of 30% is required at registration.

You will need to attach a copy of the following documents to your pre- registration form (obligatory)

## **SITEMAP - LOCATION**

The organizers reserve the right to make change to the size and position of the stands In case of bad weather and impracticable ground.

## **YOUR ARRIVAL**

The set up of exhibitors absolutely must be done according to the follow schedule :

Tuesday 15 October and Wednesday 16 October

# TRADESTANDS TERMS AND CONDITIONS



## ORGANISER

This event is organised by Le Lion Equestre hereafter called the Organisers. Applications are subject to approval by the Directors of the organising committee.

## PLACE AND DATES

The event will take place in the Parc Departemental de l'Isle Briand from Thursday 17<sup>th</sup> October until Sunday 20<sup>th</sup> October 2019.

## ADMISSION

**Tradestand applications can be made by any manufacturer, retailer or importer of any product directly or indirectly related to equestrian activities, weekend breaks or country living.**

Applications will only be considered if accompanied by full payment including VAT, and should be received by the Organisers before **9<sup>st</sup> September 2019**. No applications will be accepted after this date.

The Organisers reserve the right to refuse admission to the event to any exhibitor or prohibit the exhibition of any product without giving a reason for this decision. Any exhibitor whose application is refused will be unable to apply for entry to any similar events, nor claim any compensation. In the case of refusal of an application only the amounts paid will be refunded.

The Organisers, taking into account exhibitors' preferences wherever possible, will do the allocation of tradestands.

The Organisers reserve the right to make changes to the size and position of stands after allocation if necessary. Tradestands can not be reserved or allocated until full payment has been received.

**Exhibitors are strictly forbidden to sublet any part of their stand, either with or without payment, without the express permission of the Organisers.**

## FOOD STANDS

Under no circumstances are exhibitors allowed to sell food or drinks from their stands. Sales of sandwiches, drinks etc. are subject to a specific application.

## SET UP AND BREAKDOWN OF STAND

**The set up of exhibitors absolutely must be done according to the following schedule: Tuesday 15<sup>th</sup> October from 9:00 am to 12:00, and from 2:00 pm to 7:00 pm; Wednesday 16<sup>th</sup> October from 9:00 am to 12:00, and from 2:00 pm to 7:00 pm**

The set up of stands is the sole responsibility of the exhibitor in accordance with the terms and conditions of the event. Any deliveries of equipment or stock are the responsibility of the exhibitor. The Organisers reserve the right to store or forward any unclaimed deliveries at the risk and cost of the exhibitor. Will begin on Sunday 20<sup>th</sup> October 6:00 pm.

Breakdown of stands should be completed within half a day of the end of the event, **or by Monday 21<sup>st</sup> October at 12:00am.**

If stands are not vacated within this time the Organisers reserve the right to clear them at the risk and cost of the exhibitor, and accept no responsibility for loss or damage to any goods or property. Any damage to marquees will be charged to the exhibitor.

## APPEARANCE OF STANDS

Only products listed on the application form may be exhibited on the stand. The appearance of the stand must be maintained throughout the time the show is open. No exhibit may be covered during the opening hours of the event. The Organisers reserve the right to alter or remove any product or display which may adversely affect the appearance of the event, or any neighbouring stand., or which fails to comply with any health and safety regulations. The stand must be manned by a competent person throughout the duration of the event. In line with current legislation prices must be clearly marked on all products. Whilst the Organisers encourage the promotion and sale of exhibitors products all clearance and SALES are not allowed.

## FACILITIES

There will be toilets and showers available on site along with a reception area, visitor information point.....bars, food stands and restaurants

## STANDS

Stands consist of a white marquee. It is possible to have bare space.

Side and back walls in white marquee fabric.

Includes exhibitor parking badge and entry tickets.

Exhibitors are not authorised to exhibit outside the limits of the space booked.

The parking of vehicles, for whatever purpose, behind or next to the stands during the event is now forbidden due to new security

constraints. A carpark near to the venue will be available for this purpose.

## PAYMENT AND CANCELLATION

We would like to remind exhibitors that the organisation of this event and the tradestands is undertaken by the Organisers who will arrange for the hiring and installation of all the infrastructure required.

The Organisers become liable for hire and sub-contractors charges as soon as a tradestand is confirmed. These costs are directly proportional to the number of stands booked. A down payment request is provided at pre-registration and as a result, all applications must be accompanied by payment in full which is non refundable in the event of a cancellation. In the event of cancellation by an exhibitor any outstanding monies become due for immediate payment.

The exhibitor can, under no circumstances, claim a complete or partial refund in the event of any cancellation notified to the Organisers **after Friday 13<sup>th</sup> October**. In addition, the Organisers reserve the right to use or re-let any tradestand space booked but not occupied at the opening of the event. In this case the exhibitor will not be entitled to any refund, even partial of the stand rent paid

**Please note that payments by checks or credit cards are not accepted : payments should be made in Euros by transfert to our bank account. More informations on request.**

## ELECTRICITY

Subject to availability, the Organisers undertake to supply electricity to every stand. The Organisers responsibility ends with the supply of an electricity box and meter along with a 500w halogen spot. It is the exhibitors' responsibility to provide any additional equipment required which must comply with current regulations. **Electricity will be available every days of the event, from 8:00 am to 8:00 pm.**

## VISITORS AND EXHIBITORS

Admittance to the showground will only be given to persons in possession of a valid ticket or pass issued by the Organisers. The Organisers reserve the right to refuse entry to, or remove anyone who may pose a threat to the security or smooth running of the event.

## INSURANCE

The Organisers will not be held responsible for injury or damage to any person or object by the exhibitor. The exhibitor is covered by a public liability insurance.

## FORCE MAJEUR

The Organisers undertake to do everything within their power to ensure that this event runs on the dates and times, and at the venue stated in these terms and conditions. However, in the event of a *force majeure* the Organisers reserve the right to :

-alter the dates, times and venue for this event. In this event, the Organisers undertake to inform exhibitors of any changes as soon as they are aware of them.

-Cancel the event. If cancellation becomes necessary due to bad weather, instructions from the police or other public body, or any other incident which may cause the unavailability of the venue. In the event of cancellation no refunds of any amounts paid will be made. Exhibitors should subscribe to a suitable insurance policy to cover this eventuality.

## APPLICATION OF THE TERMS AND CONDITIONS

By signing the application form exhibitors accept all of the terms and conditions in this present document, along with any additional conditions the Organisers may need to apply in the interests of the event.

Failure to abide by these terms and conditions could result in exclusion from this event, if so desired by the Organisers.

The Organisers reserve the right to seek recompense through legal channels for any damage incurred. In event of any dispute the Court used will be that in the same Department as the registered office of the Organisers
